This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

#### **Section 6 - Accidental Release Measures**

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. ### Section 10 - Stability and Reactivity
